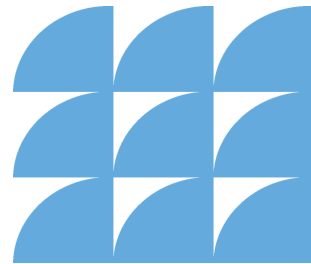
4. Confidentiality
